



# YOUR COVID-19 DISINFECTION PLAN

As part of your plan to reopen your business, it is important to have a plan for regular cleaning and disinfection to reduce the risk of exposure to COVID-19 for your employees, customers and visitors. It is also important to implement that plan according to CDC guidelines and best practices. Everyone has a role in making sure our communities are as safe as possible to reopen and remain open; we have put together this document to help make that process easy for you.

## CLEANING VERSUS DISINFECTION

- Cleaning with soap and water **REMOVES** germs, dirt, and impurities from surfaces. It lowers the risk of spreading infection.
- Disinfection **KILLS** germs on surfaces. By killing germs on a surface after cleaning, it can further lower the risk of spreading infection.

## CDC GUIDANCE FOR CLEANING AND DISINFECTION

- **Determine what needs to be cleaned.** Some surfaces only need to be cleaned with soap and water including objects that are not frequently touched or items used by children.
- **Determine what needs to be disinfected.** Frequently touched surfaces and objects will need routine disinfection using EPA approved products that are effective against COVID- 19.
- **Consider the resources and equipment needed.** Keep in mind the availability of cleaning and disinfection products and appropriate PPE. In specific instances, personnel with specialized training and equipment may be required.
- **Clean visibly dirty surfaces with soap and water.** Clean surfaces and objects using soap and water before disinfection. When you finish cleaning, wash your hands thoroughly with soap and water.
- **Use the appropriate cleaning or disinfectant product.** EPA approved disinfectants, when applied according to the label, are effective for use against COVID-19.
- **Always follow directions on the label.** Follow the instructions on the label to ensure safe and effective use of the product.
- **Continue routine cleaning and disinfection.** Clean surfaces at least daily. High touch surfaces may require more frequent cleaning and disinfection based on level of use.
- **Maintain safe behavioral practice.** Significant behavioral changes have been implemented to reduce the spread of COVID-19 – including social distancing, hand washing and wearing face coverings. Cleaning and disinfecting frequently touched surfaces and objects are part of that behavior.
- **Consider practices that reduce potential for exposure.** Consider what other steps your business can take to help reduce the spread of COVID-19 and protect your staff and the public.
